• The EC shall be administered under and subject to the terms and conditions of (i) this EC Agreement and (ii) the E 5.3.0 GENERAL TERMS AND CONDITIONS – SCANIA ENGINE PRODUCTS, as amended, of the Scania Global Warranty Manual (the "Scania Engine Terms, Conditions and Warranty"), which can be found at

In the event of any conflict between this EC Agreement and the Scania Engine Terms, Conditions and Warranty, this EC Agreement shall take precedence. Any application for coverage under the EC shall be administered through the standard Scania warranty process.
- A Torsional Vibration Calculation must have been done in order to make the EC valid.
- The EC is available for new engines only and may be purchased up to six months after the starting date of the initial engine warranty; provided the EC is not available for engines where the delivery date (warranty start date) is more than 36 months from the factory invoicing date.
- The EC purchase price must be paid in full on the purchase date. The purchase price is not refundable for any reason.

The EC requires that the engine must be maintained in accordance with the applicable Scania Service and Operators manual. All repairs and maintenance conducted under the EC must be carried out by a properly trained technician and according to Scania manuals and procedures, using only Scania original parts (including service exchange) and approved lubrication oil and coolant. It is recommended that Operational data to be stored and uploaded to Scania at every maintenance cycle. The EC does not cover (a) modifications required by law as a consequence of changes occurring after the engine purchase date or (b) damages resulting from corrosion on exterior surfaces. A maintenance logg book must be filled in and a copy shall be provided to Scania upon request.

- The EC period will not be extended for any period of time during which the engine is not used, hibernated or otherwise inactive.
- The EC shall be applicable to the engine specified above and is transferable with the engine; provided that Scania should be informed of any transfer in accordance with its usual policies and procedures.
- The EC is not intended to be offered in any state or jurisdiction where such offering is not authorized or is unlawful under applicable law and any such offering is void. Furthermore, notwithstanding any other provision of the EC, no provision of the EC is an attempt to exclude or limit rights in a manner that violates applicable law. Any provision of the EC which is unenforceable under applicable law is excluded and the remaining provisions should be enforced without the unenforceable provision.
- Failure to abide by the terms and conditions of the EC result in the EC being deemed void and unenforceable.

By placing an order for EC on the above engine, all parties hereby agree to the terms and conditions stated in this EC Agreement and acknowledge, ratify and confirm the terms and conditions of the Scania Engine Terms, Conditions and Warranty to the Scania engine described above.
