Extended Coverage ensures both cost control and uptime, while Extended Storage increases flexibility. All with the purpose of giving you peace of mind to focus on your core business.

EXTENDED COVERAGE

Expanding our commitment to exceptional quality and unsurpassed service with a full extension of the Scania Basic Warranty terms, without any deductibles or hidden inclusions. Extended Coverage can be purchased for up to 5 years or 10,000 running hours, either together with the engine or during the first 180 days after the Start of Warranty date.

For proactive high-level service with minimised downtime, connectivity is obligatory. Remote Diagnostics comes at no extra charge when engines are ordered with extended coverage. This enables us to diagnose the engine remotely, to accurately advise the operator, and to bring the correct tools and parts for any on-site repairs.

Requirements

A Scania Communicator unit is required. See Scania Operators Manual or contact your Scania representative for more details.

EXTENDED STORAGE

Extended Storage allows the engine to be stored either at Scania or a customer facility for longer without initiating the Basic Warranty period. This prolongation provide manufacturers with additional time for installation, sales or with an opportunity to ensure end-users obtain the full Basic Warranty period.

It applies to engines not yet in use, whether installed or not, and can be purchased during the Basic Warranty window, that is the maximum time available for utilising the Basic Warranty.


