**Terms and Conditions**



- 1) **Promoter.** This free prize draw is being organised and administered by Scania (Great Britain) Limited (company number 00831017) at Delaware Drive, Tongwell, Milton Keynes, MK15 8HB ("Scania"). The prize draw administrator shall be a member of Scania's marketing team.
- 2) **Terms and conditions.** These are the terms and conditions that will apply to your entry of the prize draw. Please read them carefully before you enter the prize draw. By entering the prize draw, you confirm your acceptance of these terms and conditions.
