



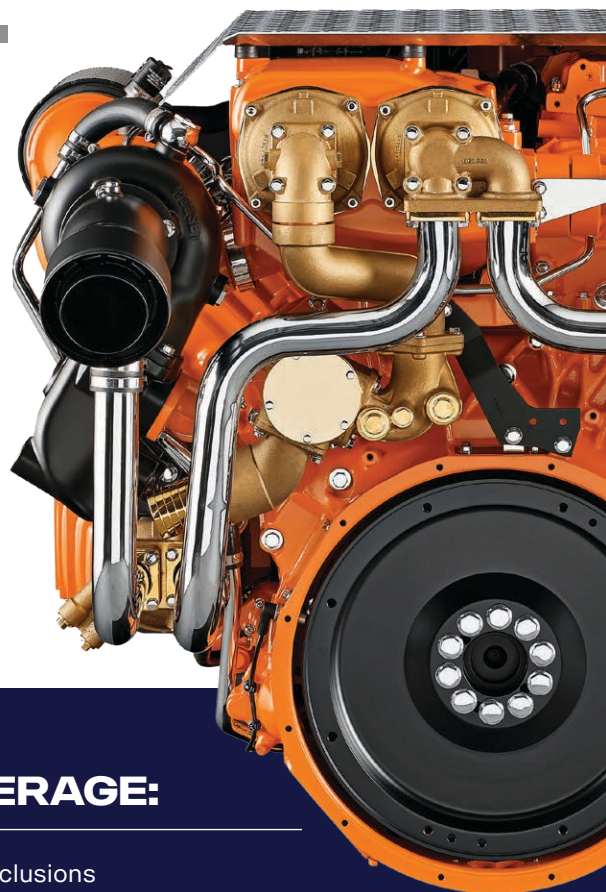

For all Scania marine engines, the basic warranty period is a minimum of 12 months from the day the engine was taken into operation, but not beyond 60 months counted from the date the engine was delivered from the Scania factory.

\* This extended coverage product is in addition to the basic mechanical warranty and does not change the engine's designed useful life.

## CONDITIONS FOR WARRANTY

The warranty is only valid if the engine is used within the engine's power definition listed below.

### ALL-SPEED ENGINES

#### ICFN – Continuous service, Work Boat:

Unlimited hr / year at a total load factor of 100%.

#### IFN – Intermittent service, Work Boat:

Intended for intermittent use where rated power is available 1 hr out of 3 hrs at 100% load. Accumulated load factor must not exceed 80% of rated power. Unlimited hr / year service time.

#### PCL – Intermittent service, Patrol Craft Long:

Intended for intermittent use where rated power is available 1 hr out of 6 hrs at 100% load. Between full load operations engine RPM must be reduced at least 10% from rated RPM. Accumulated total service time max. 2000 hrs / year.

#### PCS – Intermittent service, Patrol Craft Short:

Intended for intermittent use where rated power is available 1 hr out of every 12 hrs at 100% load. Between full load operations, engine RPM must be reduced at least 10% from rated RPM. Accumulated total service time max. 1200 hrs / year.

#### REC – Recreational service:

Intended for recreational use where rated power is available 1 hr out of 20 hrs at 100% load. Between full load operations, engine RPM must be reduced at least 10% from rated RPM. Accumulated total service time max 500 hrs / year.

### AUXILIARY ENGINES

#### PRP – Prime power:

Varying load. 1 hr out of 12 hrs of accumulated peak overload to 110%. For continuous operation and unlimited yearly operation time at varying load and with a maximum mean load factory of 70% of rated power.

## EXTENDED PRODUCT SUPPORT

Extended product support is applicable according to Scania's continuously updated Extended Product Support (EPS) list. The most important components are subject to extended product support as listed to the right.
